Agenda Item #1 Call to Order & Approval of Agenda

Chairman Joe Waggoner called the meeting to order. Commissioners Waggoner, Ron Patterson, Jim Best and the General Manager were in attendance.

Commissioner Waggoner brought the October agenda before the Commissioners. Commissioner Best made motion to approve; Commissioner Patterson seconded. The agenda was unanimously approved.

Agenda Item # 2 Approval of September 2020 Minutes

Commissioner Waggoner presented the September 2020 Commissioners Meeting minutes for approval. Motion to approve was made by Commissioner Patterson; Commissioner Best seconded. The Commissioners unanimously approved and signed the September 2020 minutes.

Agenda Item # 3 Old Business

<u>NEXT Internet Service installed at Omaha Center</u>: Internet service has been installed at the Omaha Center, and is ready to go for the upcoming general election on November 3. Highland School District has not put their hotspot in yet.

<u>4-A Boys State at North Oct 6 & 7 completed</u>: Fifty-five kids from across the state participated in the tournament; weather was perfect. A total of about 200 people attended.

Watersides of Aztec, Chanute, Omaha & Navajo completed: The watersides of Aztec, Chanute & Omaha dams are complete; Navajo is in the works. We had inmates in from Calico Rock prison to help on the backside of Sequoyah dam; they plan to be back this week, weather permitting.

<u>Xylem Contractor for Entergy work completed in Canal</u>: Xylem has completed their work. Another contractor will be in later in the month to do some hydro-seeding in the canal.

<u>Lake Cherokee Drawdown</u>: We were able to survey 26 of 36 homeowners along Lake Cherokee via phone of the proposed drawdown; everyone was in favor. The remaining homeowners were notified via letter and attempted personal contact by a Lake Safety officer. The initial drawdown of about two feet began today.

<u>Rebel Booster Club Tournament canceled</u>: The Rebel Booster Club Golf Tournament scheduled for October 17, 2020 was canceled.

<u>Election in Omaha Center on Tuesday, November 3</u>: (This was discussed in the first bullet point under Old Business.) General Election voting will be held at the Omaha Center for Fulton County residents.

<u>Backsides of Sequoyah, Thunderbird, Omaha & Navajo Dams</u>: GM Webb noted that when the prisoners come back, they will likely be at Sequoyah.

<u>Survey on dropping Lake Cherokee / 26 of 36 in favor / other 10 no reply</u>: (This was discussed under old business.)

Through 9/30/2020, total expenditures were \$1,816,803, which is 67.14% of the projected budget with 75.00% of the year passed.
