RESOLUTION OF THE COMMISSIONERS ADOPTING, RATIFYING, AND APPROVING THE WATERCRAFT REGULATIONS FOR THE OPERATION OF WATERCRAFT ON THE LAKES OF CHEROKEE VILLAGE

The undersigned Commissioners of the Cherokee Village Road and Street, Recreational and Fire Department Suburban Improvement District No. 1 (hereinafter the "CVSID"), hereby adopt, ratify and approve the following:

WHEREAS, the CVSID encourages all authorized watercraft operators to enjoy the recreational activities offered by the CVSID on the lakes of Cherokee Village;

WHEREAS, like driving an automobile, operating a watercraft on the lakes of Cherokee Village is a privilege and not a right;

WHEREAS, because of dangerous activity observed on the lakes of Cherokee Village, the CVSID's Lake Committee recommended that the CVSID adopt, ratify, and approve certain rules and regulations that govern watercraft and those authorized individuals operating watercraft on any of the lakes of Cherokee Village;

WHEERAS, the Watercraft Regulations drafted by the CVSID and adopted, ratified, and approved by this Resolution are attached to this Resolution as Exhibit A and are approved to ensure that persons and real and personal property are protected while watercraft is operated on any of the lakes of Cherokee Village;

WHEREAS, the Watercraft Regulations drafted by the CVSID and adopted, ratified, and approved by this Resolution are modeled after the rules and regulations of the Arkansas Game and Fish Commission, the rules and regulations of the United States Coast Guard, the now existing guidelines of the CVSID, the watercraft regulations of Bella Vista, Arkansas, and the watercraft regulations of Hot Springs Village, Arkansas;

WHEREAS, watercraft operators on the lakes of Cherokee Village, in addition to the Watercraft Regulations drafted by the CVSID and adopted, ratified, and approved by this Resolution, must also comply with all Arkansas laws, the rules and regulations of the Arkansas Game and Fish Commission, and the rules and regulations of the United States Coast Guard concerning the operation of watercraft;

WHEREAS, the commissioners of the CVSID have adopted, ratified, and approved the Watercraft Regulations, which are attached to this Resolution as Exhibit A;

BE IT RESOLVED that the Watercraft Regulations attached to this Resolution as Exhibit A are hereby adopted, ratified, and approved by the Commissioners of the CVSID and the Secretary of the CVSID and General Manager of the CVSID are hereby authorized and directed to take all further actions necessary to implement this Resolution and the Watercraft Regulations adopted, ratified, and approved by this Resolution.

The undersigned Commissioners of the CVSID hereby acknowledge and consent to the foregoing action.

A copy of this Resolution and the adopted, ratified, and approved Watercraft Regulations attached hereto as Exhibit A shall be filed with the Secretary of the CVSID for inclusion in the CVSID's minute book and on the CVSID's website.
