- Jeff Donahue Red Feather list of lots available? Betsy Waugh states: says we do not have a physical list, need lot block sub division, parcel number plat number and we will help you through the process
- Carissa Cantwell; 3 Caddo; who cares who buys lots, but same offer for all no special deals for anyone.
   Why don't you have a list of physical lots?
  - o Betsy Waugh replies: SID has had no control over sell of lots for the past 30+ years. Since July when previous commissioners chose not to pay taxes and keep in our inventory, some lots have

become delinquent. It is a great big mess. Each county provides us with copies of deeds that we enter into our system. This whole process is new to all of us.

  - O Betsy Waugh asks: Do you have something in writing with a law or statue that we can track, do research on. Not asking for an email, we are looking for actual law quoted to Mr. Webb. Anything that you can provide that would be appreciated, so we are all reading the same information. Mr. Gruger stated: hire an attorney who knows SID law. David Nebel / Ron Page, stop the nastiness.
