## **Rules and Regulations for Cherokee Village Golf Courses**


- 1. All golfers must register in the Cherokee Village Suburban Improvement District ("CVSID") golf shop before commencing play and must present their property owner card upon request.
- 2. Daily cart path rules will be posted in the golf shop and at the hole No. 1 and No. 10 tee boxes.
- 3. Players must begin play on hole No. 1. Players wishing to begin play on any other hole must request approval from the golf shop.
- 4. Carts should always remain 50 feet from the green . Signage should direct players where to return to the cart path. Handicap players with appropriate signage on their golf cart or otherwise conspicuously shown may maintain a distance of 15 feet from the green.
- 5. Players in foursomes have precedence over singles and twosomes. Players are encouraged to allow faster players the opportunity to play through the course. The golf shop reserves the right to pair players or groups to form a threesome or foursome to increase the efficiency of gameplay.
- 6. Golfers must wear appropriate attire on the golf course and driving range. T-shirts, tank tops, sport bras, and gym shorts are not acceptable attire. All golfers must wear proper length shorts. If you are unsure about appropriate attire, please check with the Golf Shop.
- 7. Fivesomes may be allowed on the course, as long as they maintain proper pace of play with other groups.
- 8. Each player must have their own set of clubs.
- 9. No more than two players are permitted on a CVSID rental cart. Rental cart operators must be at least 18 years of age and possess a valid driver's license.
- 10. Golfers shall not use greens, bunkers, fairways, or tee boxes for practice purposes.
- 11. Cart paths are reserved exclusively for registered golfers during business hours. Property owners are not permitted to walk on the cart paths paths at any time, including during the hours before and after the golf courses are open for business.
- 12. Golf carts, CVSID designated equipment and emergency vehicles are the only vehicles permitted to be operated on the golf courses. Unauthorized vehicles, their operators, and all occupants shall be classified as trespassers and subject to prosecution.

Individuals in violation of course rules and regulations will be notified of their infraction and requested to comply. Failure to comply will result in penalties being assessed as follows:

First offense: Verbal Warning Second offense: Warning letter

Third offense: Suspension of golfing privileges for 3 days

A suspension may be appealed to the CVSID Board of Commissioners. The General Manager will establish a time and date for the appeal hearing. The imposition of the penalty will be postponed pending the outcome of the appeal hearing. The CVSID Board of Commissioners reserves the right to impose additional penalties as related to the degree of violation.
